## Alaska Small Community Emergency Travel Order

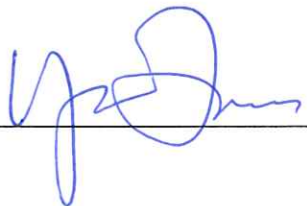
The City of Kake is issuing a "No Travel Ban to and from Kake Alaska, Effective 11:59 p.m. March 30, 2020, until April 15, 2020 and will be Reassessed on April 15<sup>th</sup> to determine if Ban will be extended or revised.

- i. Emergency First Responders (includes fire, ambulatory services, and other similar emergency first responders).
- ii. Law Enforcement acting within their official duties (this includes federal, state, and local law enforcement personnel); and
- iii. Office of Children's Services personnel responding to reports of child abuse of neglect and insuring child safety.
- iv. Critical Infra-Structure Related

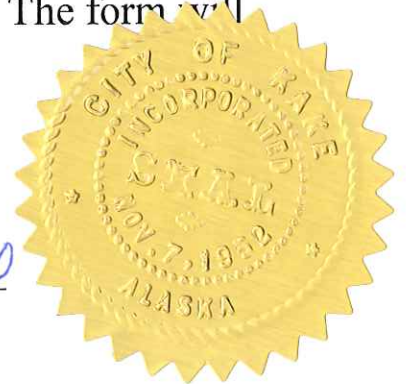
